## STATEMENT REGARDING REACH Regulation (EC) No. 1907/2006

In accordance with Article 33 of Regulation No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH), TIKI HVAC, d.o.o., Velenje, Slovenia has a duty to communicate to its customers the presence of Substances of Very High Concern (SVHC) contained in its articles in excess of 0.1% weight by weight (w/w) (as defined by the Court of Justice of the European Union Case C-106/14).
